## **Dear colleagues!**

We invite you to take part in the annual international scientific conference "Science in sport: modern issues" organized by the Armenian State Institute of Physical Culture and Sport. The conference will be held in Yerevan from 11<sup>th</sup> to 13<sup>th</sup> of October, 2022. Venue: Alec Manukyan 11 (ASIPCS main building).

## **Basic sections of the journal**

- 1. Olympic sport: Olympism, Olympic education and legacy in the modern sport.
- 2. Pedagogical issues of physical culture and sport.
- 3. Development of psychological conception in terms of sport activity.
- 4. Medical biological aspects of sport activity and healthy life style.
- 5. Physical rehabilitation in sport.
- 6. Adaptive sport in the modern society.
- 7. Sport tourism and perspectives of its development.
- 8. Innovative technologies in the process of sport management.

# The articles are accepted in Armenian, English and Russian. Submission deadline for scientific manuscripts is set for the 1<sup>st</sup> of April, 2022.

# Technical requirements

On the top left-hand corner *Universal Decimal Classification* – <u>UDC ( $Y_{A}K$ ) code</u> of the article must be indicated,

On the top and in the center of the page the article title must be written in bold, 1 interval below: on the right *ORCID number (SCOPUS ID, E LIbrary –ID, if available)*, 1 interval below: the authors' (not more than 3) academic degree, title, name initials, surname fully (in bold),

1 interval below: on the right the complete name of organization, country, city (in bold),

1 interval below: the e-mail of author(s) (in bold),

1 interval below: keywords (8-10 words) across the width of the page,

1 interval below: the main text presented in a separate paragraph.

The whole volume of the article must include **6-8 full pages (including tables, diagrams)**.

The paper size must be A4 (210-297mm), in MS Word 2007 format, in GHEA Grapalat (Armenian), Times New Roman (English and Russian), 12-point font, with the text justified and no word divisions.

Articles must be single-spaced with 1 cm first-line indentation and have a 2cm margin on both the right and left.

Main body: formatted as keywords, relevance, research aim, research problems, etc. (in bold).

# **TEXT STRUCTURE**

Key words.

**Research relevance.** The section includes the issue study importance, state and its reflection in literary sources.

## Research aim, problems.

#### Research methods and organization.

Here the methods, devices, selection, research conditions (place, duration, period of time) applied during the research are stated in one line.

#### Analysis of research results.

In this section the data, facts obtained in the result of the research are presented and analyzed, tables and diagrams (totally not more than 2) are placed.

#### Conclusion.

The section must comprise the conclusions based on the research results without repeating the formulations given in other sections of the article (recommendations are also acceptable)

# References.

No less than 5 and no more than 10 literary sources must be numbered and listed alphabetically. The references in the language of the article are preceded by those in foreign languages. In-text citations are put in square brackets [], with the ordinal number of the reference source, e.g. [3] or [1,5,6]:

The reference list must be followed by information about the article and summaries in 2 languages: for Armenian text –Russian and English, for Russian text – Armenian and English, for English text- Armenian and Russian.

In the center of the page the article title must be written in bold,

1 interval below: on the right the author's (no more than 3) academic degree, title, name initials, surname fully (in bold),

1 interval below: on the right the complete name of organization, country, city (in bold),

1 interval below: keywords of the article (8-10 words)

1 interval below: the abstract (АННОТАЦИЯ) of the text within 230-250 words.

### Abstract must contain

### 1. Key words

- 2. The aim of the research
- 3. Methods and organization of the research

# 4. Analysis of final results

## 5. Brief conclusion

The abstracts in foreign languages are of great importance, as they include all the necessary information regarding the article for foreign specialists of the field. Based on it the specialist can study the article thoroughly and compile adequate referencing.

The articles not meeting the above mentioned requirements will not be accepted nor sent to the editorial committee for further reviewing. Only after the positive conclusion of the editorial committee the corresponding payment should be made. The author is informed about the article acceptance, necessary corrections or refusal through email within 10 working days.

It is required to present the materials in electronic version and printed in one example.

The article must not have been published elsewhere.

The author takes the responsibility for the article content.

Each author can present no more than 2 manuscripts.

Each article is assigned a digital object identifier, DOI.

The article should be submitted *with a review by a scientist or a leading specialist in the field.* 

The price for each printed page of the article is defined as follows: 1000 AMD for the Institute personnel, 2000 AMD for the lecturers of other Armenian universities, 4000 AMD for the lecturers of foreign universities (amount equal to foreign currency of the RA).

# The ASIPCS post-graduates, applicants (without co-authors) and doctors do not make predefined payment for article publication.

The price of each issue of the journal is 3000 AMD, for the lecturers of CIS universities is 10.000 AMD including postal delivery.

The countries ASIPCS cooperates with in scientific-educational field are not charged for the article publication.
