Requirements to materials

1. On the top of the page, in the center the article title must be written in capital letters in bold,

- 1 interval below: the faculty, the department, the course, the full name and the surname of the author of the article; in **bold**
- I interval below: the academic degree, the title, the initials of the first and the middle names, the full surname of the scientific supervisor; in **bold**
- > 1 interval below on the right: names of the organization, city, country: in bold
- I interval below, from the right: the e-mail addresses of the author of the article and the supervisor.
- the key words and phrases of the material (5-8 words) should be written in a separate paragraph. The text itself should be written one interval below

2. The whole volume of the article must comprise from **3 to 5 full pages (including tables, diagrams).**

The paper size must be A4 (210x297mm), in MS Word 2007 format, in GHEA Grapalat (Armenian), Times New Roman (English and Russian), with font 12, with the text justified and no word divisions.

Line spacing should be 1, with 2 cm margin on each side of the page.

Text structure

• Key words.

• **Research relevance.** The section includes the importance of the study of the issue, its state and its reflection in literary sources.

- Research aim, problems.
- 1

• Research methods and organization.

Here the methods, devices, selection, research conditions (place, duration, and period) applied during the research are mentioned in one line.

• Research results analysis.

In this section the data and facts obtained in the result of the research are presented and analyzed, tables and diagrams, if necessary, (totally not more than 2) are placed.

• Conclusion.

The section must comprise of conclusions based on the research results without repeating the formulations given in other sections of the article (suggestions are also acceptable)

• References.

From three to five literary sources must be numbered and listed alphabetically.

The references in the language of the article are preceded by those in foreign languages. In-text references are enclosed in square brackets [], indicating the serial number of the source of literature, for example, [2] or [1, 3].

At the end of the article, you can thank your supervisor for his support in the scientific work on the preparation of the article.

The best articles will be published in "Sport, Health, Education" Student Scientific Journal.
