INTRODUCTION

This General Cooperation Agreement (hereinafter Agreement) is being entered into to establish relationship and cooperation in education, research, culture and sport in both Institutions. The Armenian State Institute of Physical Culture and Sport (hereinafter ASIPCS) and National University of Physical Education and Sport of Ukraine (hereinafter NUPES) will collaborate on the basis of reciprocity, with each of the parties responsible for the efficient implementation of the activities defined in the articles below.

ARTICLE 1. Parties agree to develop mutual and lasting understanding with the objective to execute joint educational, cultural and scientific projects.

The cooperation will be accomplished on the basis of mutual respect, must be coherent with the laws of the both countries and must be in accordance with the internal educational and administrative regulations of both Parties.

ARTICLE 2. Parties agree to set complex of the main joint activities, which could be described as following:

- Development of the academic mobility programmes for the professors, scholars on the different education levels (undergraduate, graduate and postgraduate) and administrators through mutual visits;
- Enhancement of the teaching methods, research and academic work;
- Design and further development of joint education programmes;
- Realization of joint research scientific projects and programmes;
- Exchange of scientific and didactic materials, processing and publication of the joint scientific work;
- Arrangement of the joint activities and events, such as seminars, conferences, etc.

ARTICLE 3. Each project or activity, identified as being of common interest, will be described in a Separate Agreements which will include the terms and conditions for cooperation, responsibilities of the Parties, and the administrative and financial details for its implementation.


ARTICLE 4. Each project or activity agreed in Separate Agreements will be funded individually, according to the resources available. The resources needed to implement such projects or activities will be negotiated with suitable funding agencies by the project coordinators, supported by both Parties. Likewise and depending on resources available, the Parties will develop activities funded with their own financial resources.


ARTICLE 5. This Agreement is valid for a period of five (5) years, and will automatically be renewed for additional 5-years period, unless one of the contracting Parties notifies the other in writing its intent to terminate at least three (3) months in advance of termination date.


This Agreement is valid from the signing date.
